GENERAL ADMINISTRATION POLICIES AND PROCEDURES Confidential Incoming Communications

Policy Number: 103

Adopted: December 15, 2022

Policy and Purpose

The purpose of this policy is to address the protection of confidential information about (1) a case involving an indigent person including attorney-client privileged communication and/or attorney work product, and (2) inadvertently sent to the Idaho State Public Defense Commission (PDC) and/or unrelated to Commission business. This policy supersedes any duplicate or conflicting policies previously adopted by the PDC.

Chapter 1, Title 74, Idaho Code Idaho Code §74-105(18)

Under the Idaho Public Records Act certain confidential information is exempt from disclosure. Chapter 1, Title 74, Idaho Code. And under Idaho Code §74-105(18) specific PDC records are exempt from disclosure. Accordingly, the PDC will take appropriate actions to protect confidential information including attorney-client privileged communication and/or attorney work product about a case involving an indigent person or other confidential information inadvertently communicated to the PDC and/or unrelated to PDC business.

When the PDC receives confidential information the sender intentionally communicated to the PDC,

- PDC Staff will advise the communicator that confidential information should not be disclosed to
 the PDC because the PDC may have to disclose it as public record and/or litigation discovery. PDC
 Staff will attempt to understand the communicator's information/resource needs and provide or
 direct them to relevant information/resources.
- PDC Staff will save all such confidential correspondence in the S: drive so that it is available to the Deputy Attorney General (and their staff) assigned to represent the PDC in any litigation for appropriate disclosure pursuant to such litigation.
- PDC Staff will utilize the following correspondence to respond to confidential communications about a case involving an indigent person, which correspondence may be adapted to the particular communication and/or amended by PDC Staff from time to time.

Toward that mission, the PDC collects data, supports compliance with standards, provides training and administers financial assistance. The PDC does not have the statutory authority to advise you or to intervene in cases involving indigent persons.

When the PDC receives confidential information the sender inadvertently communicated to the PDC, PDC Staff will notify the sender and delete any electronic copies and shred any paper copies.
